REDUCING ALCOHOL RELATED HARM

- ✓ RARHA is a Member States initiative that exists from an initiative from EC and CNAPA
- ✓ We have on board 27 from the 28 European Union Member States, plus Iceland, Norway and Switzerland
- ✓ 32 Associated Partners and 28 Collaborating Partners, including WHO, EMCDDA, OECD and Pompidou Group are participating in the Joint Action
- ✓ CNAPA is a committee comprised by representative from Member States

As decided by the Management Group (MG) :

- ✓ The Advisory Group (AG) comprises the members of the *Committee on National Alcohol Policy and Action* (CNAPA), plus Iceland, Norway and Switzerland and, as observers, European Monitoring Centre for Drugs and Drug Addiction (EMCDDA), World Health Organization/Regional Office for Europe (WHO/Europe), Organization for Economic Cooperation and Development (OECD Health Division) and Pompidou Group.

Advisory Group (AG)

- ✓ AG main responsibilities' will be to oversee the progress being made in regards to crucial issues related to the sustainability of the Action work and results.
- ✓ It also discusses and advises, in particular, on options for the continuation of common EU alcohol surveys, as well
- ✓ Provides strategic guidance and support to the MG to ensure that the expected results meet the Action's objectives.

- ✓ supervise the advancement of the Action;
- ✓ review the project outcomes and identify the strong/weak points with respect to the objectives of their execution;
- ✓ promote the visibility of the Action at national level and link it to other relevant national, EU and international efforts .

- ✓ AG will meet 3 times during the course of the Action and will be convened back to back with CNAPA meetings.
- ✓ The AG will designate a Chair among CNAPA members.
- ✓ The meetings will be prepared by the Coordinator together with the AG chair and the MG.

- ✓ If necessary the AG can be consulted, on specific issues, by written procedure.
